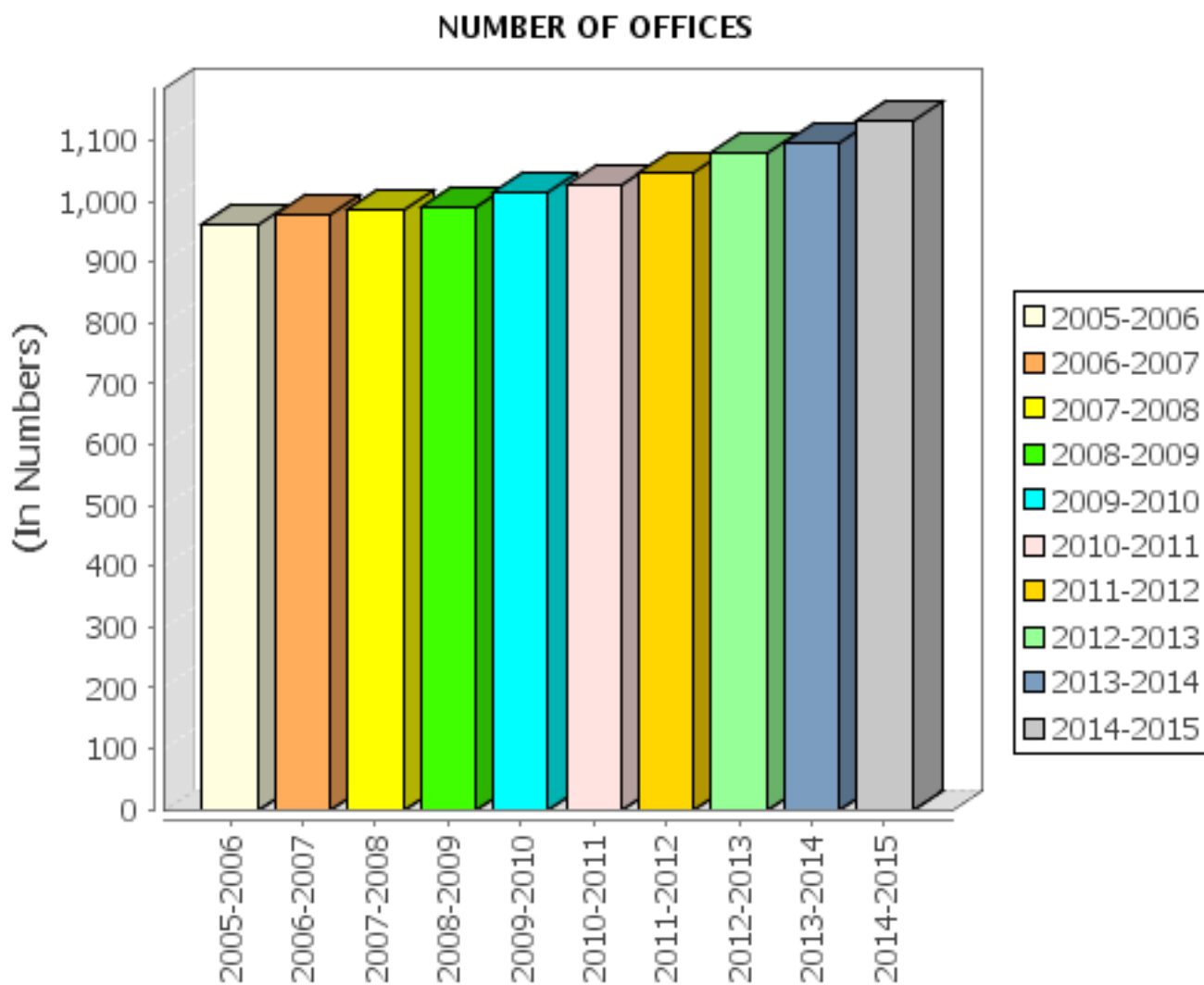

PERFORMANCE OF STATE COOPERATIVE BANKS OVER A DECADE (2006-2015)

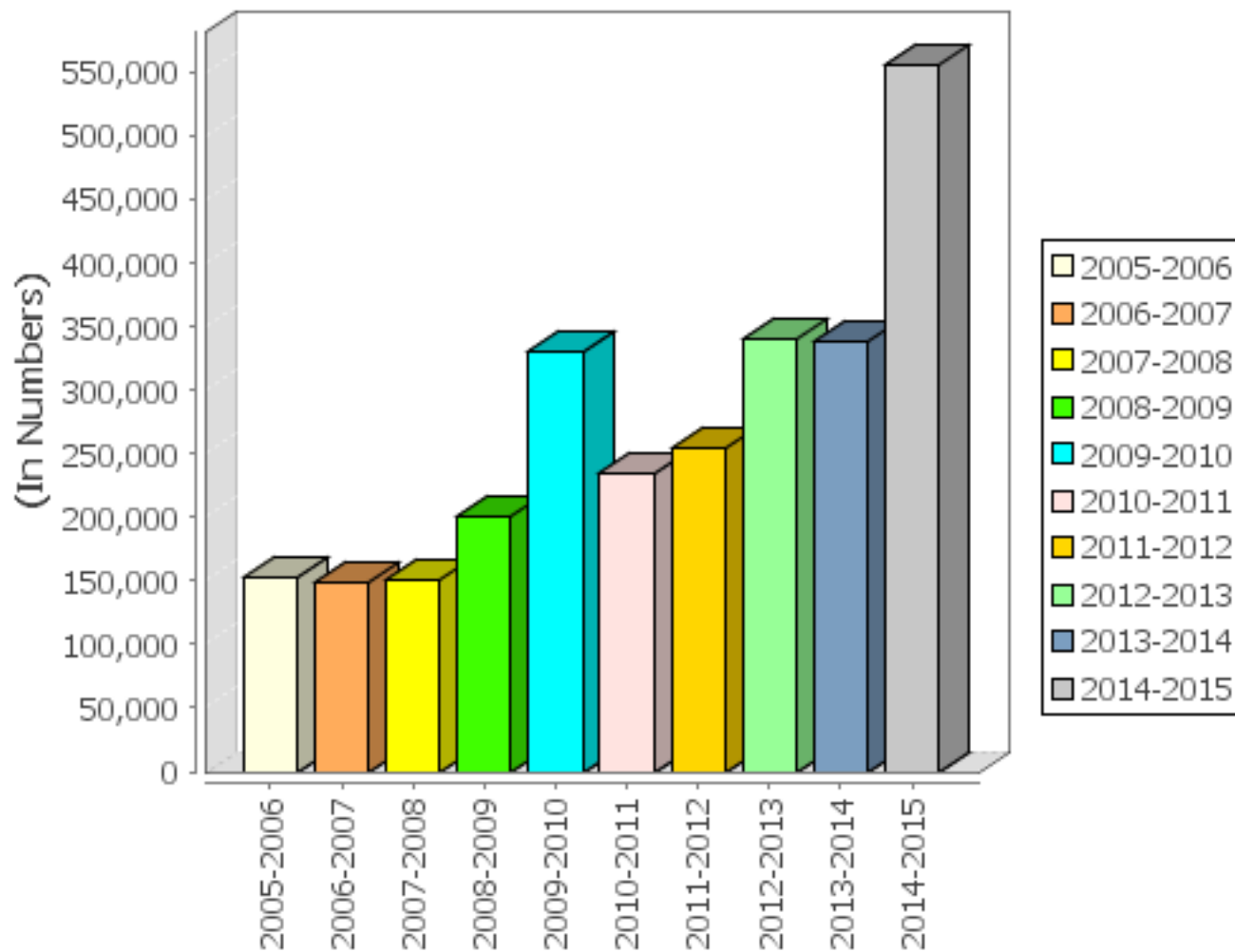

TOTAL MEMBERSHIP

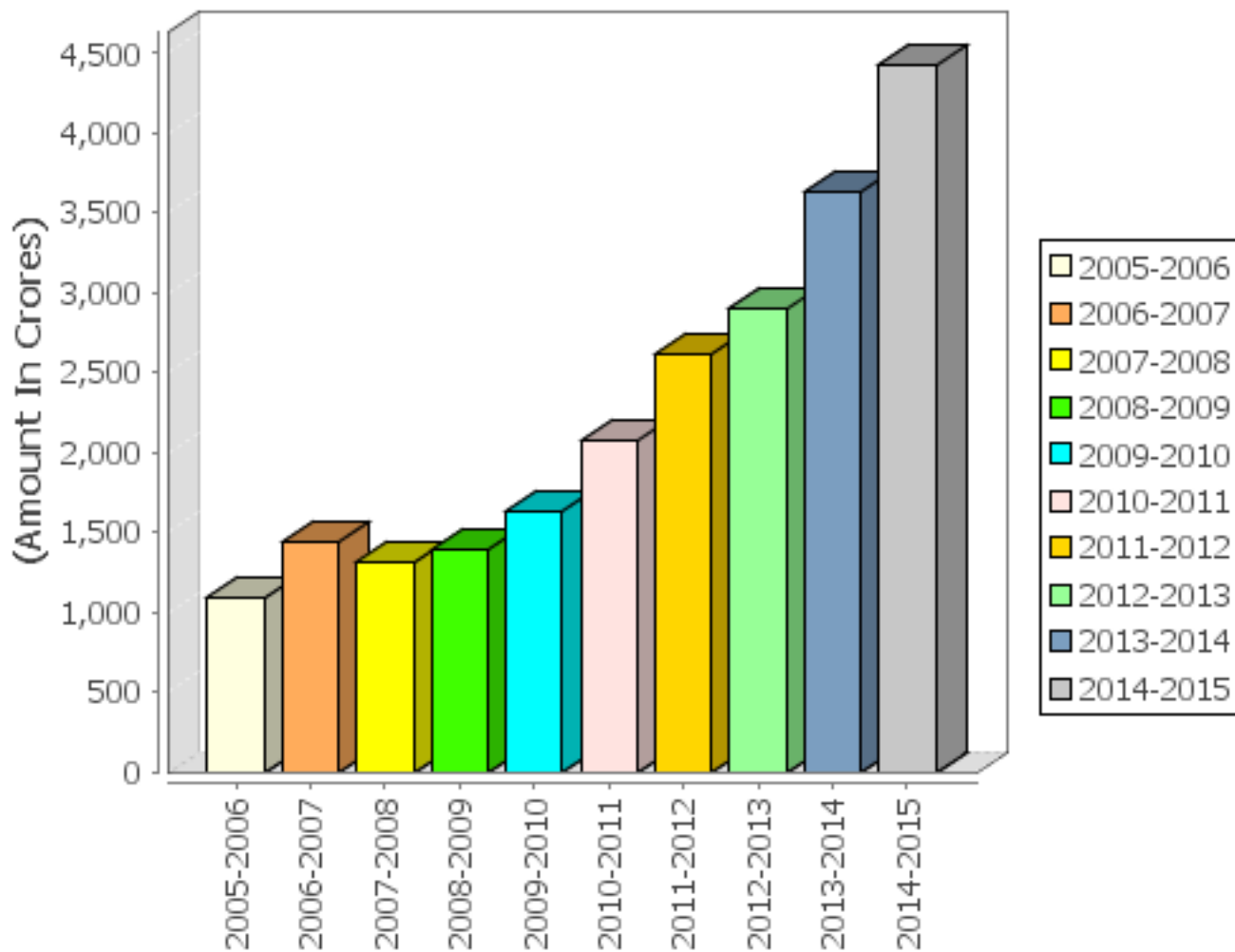

PAID UP SHARE CAPITAL

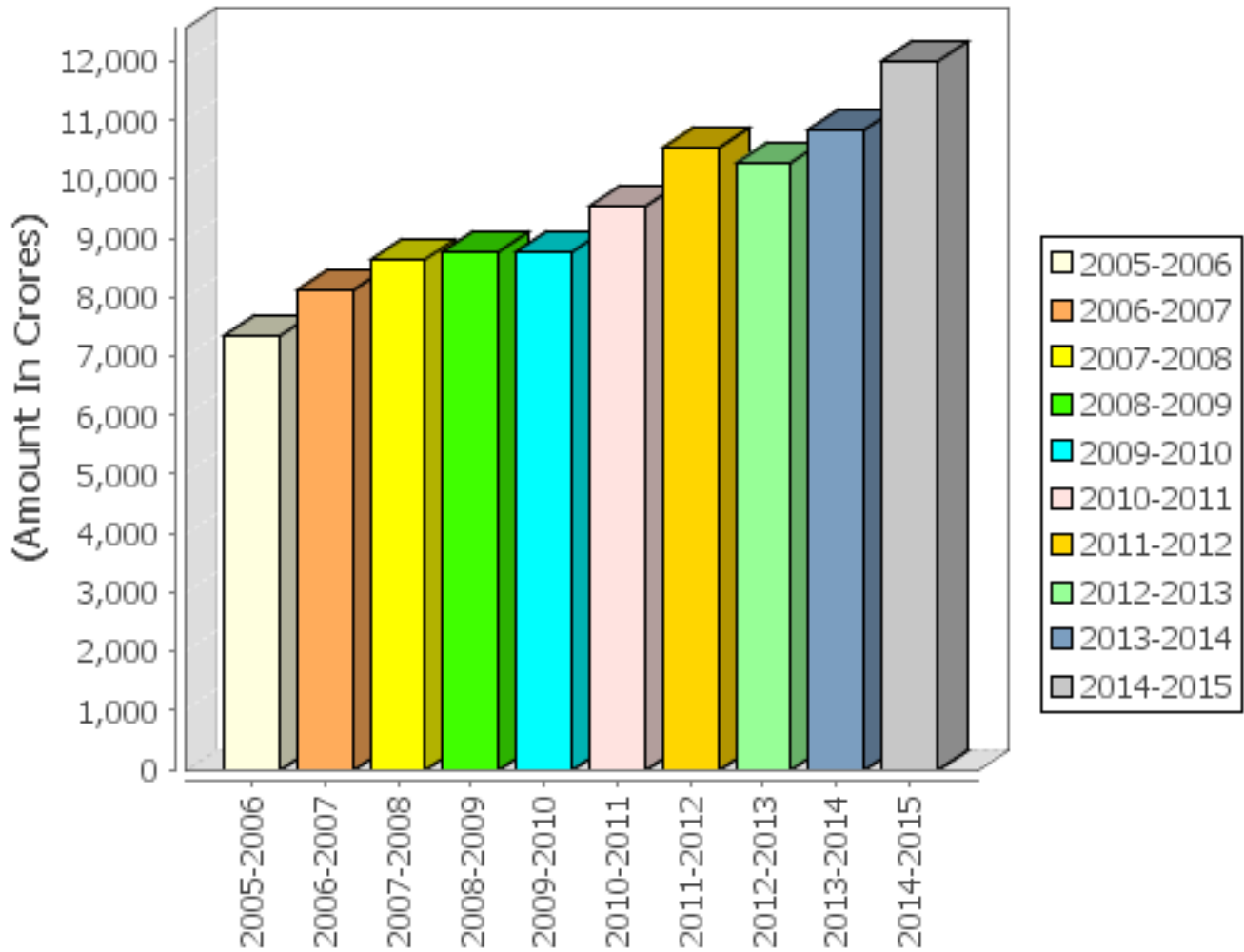

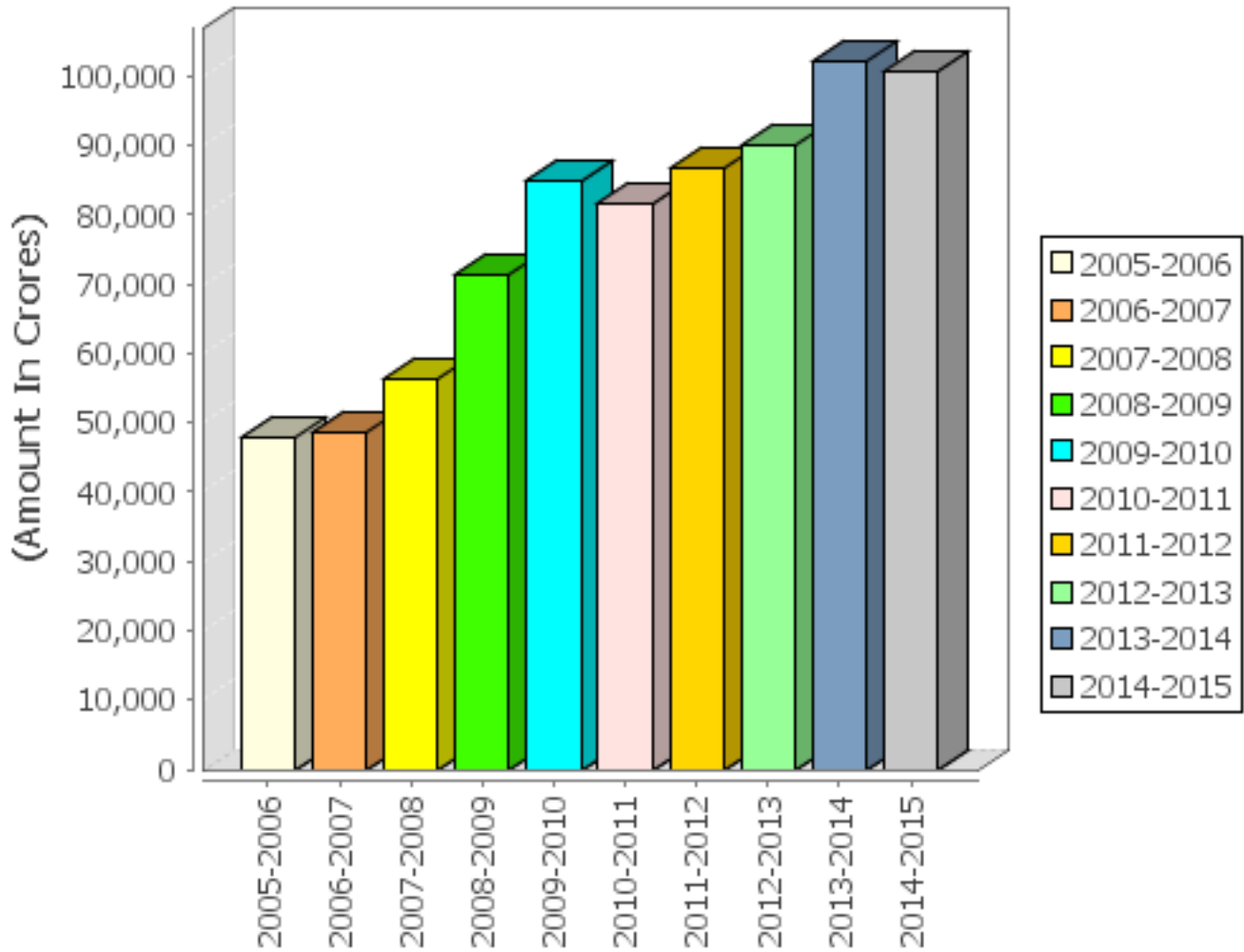

TOTAL DEPOSITS

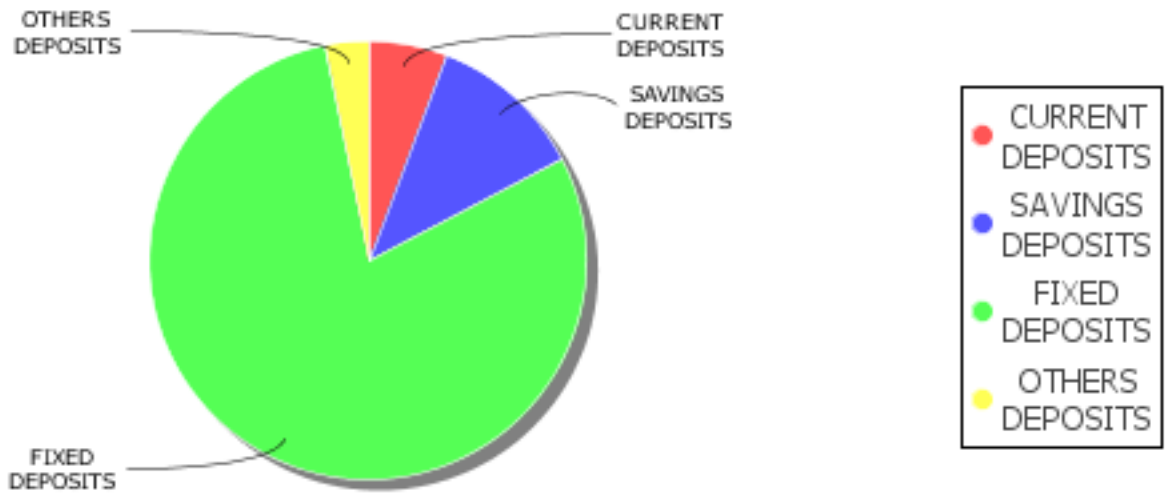

TYPE OF DEPOSITS

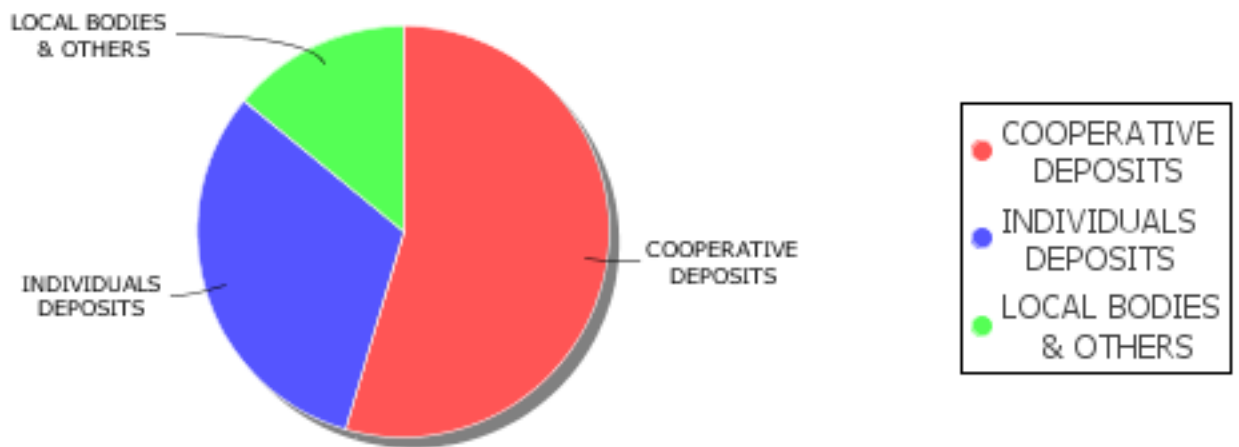

COMPOSITION OF DEPOSITS

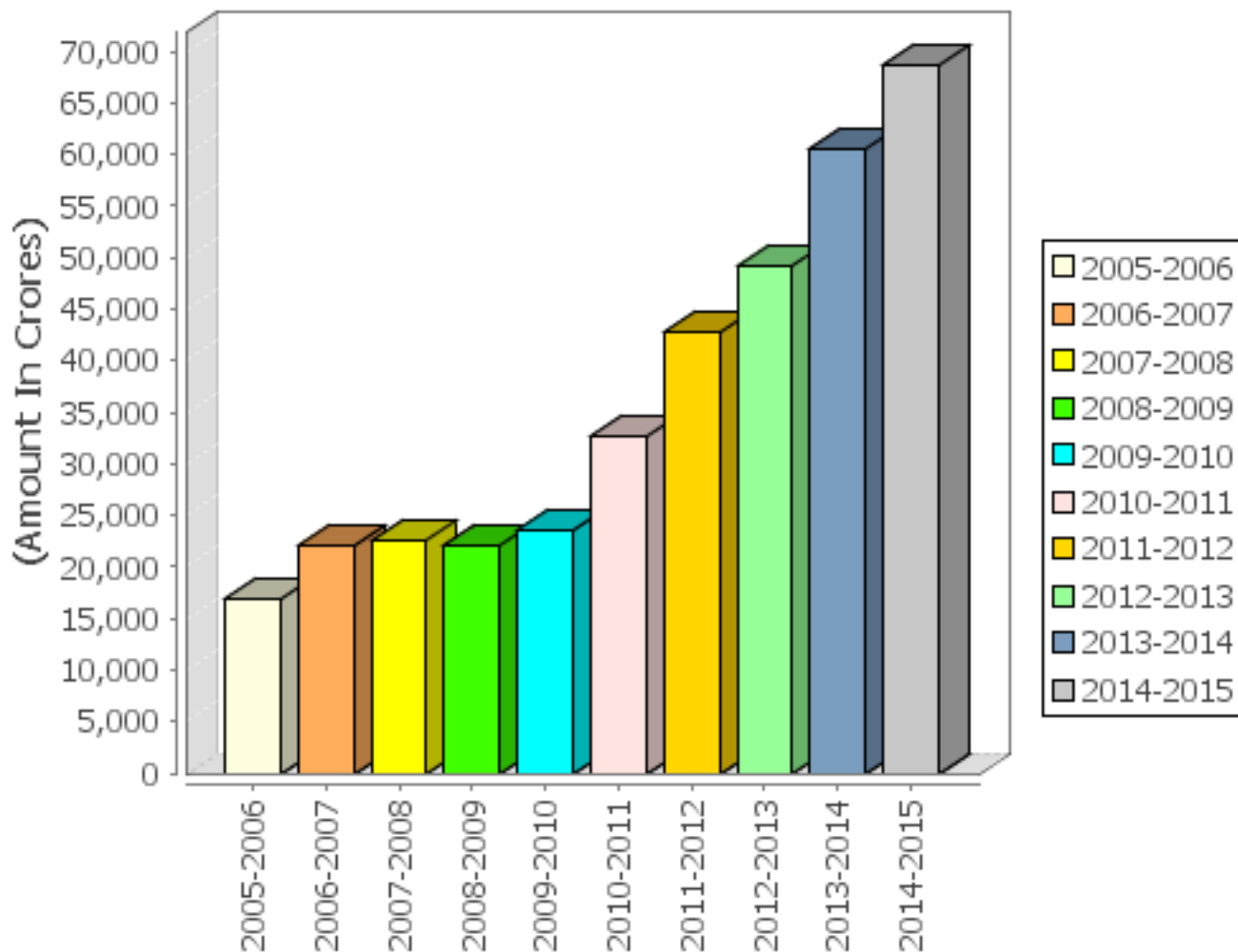

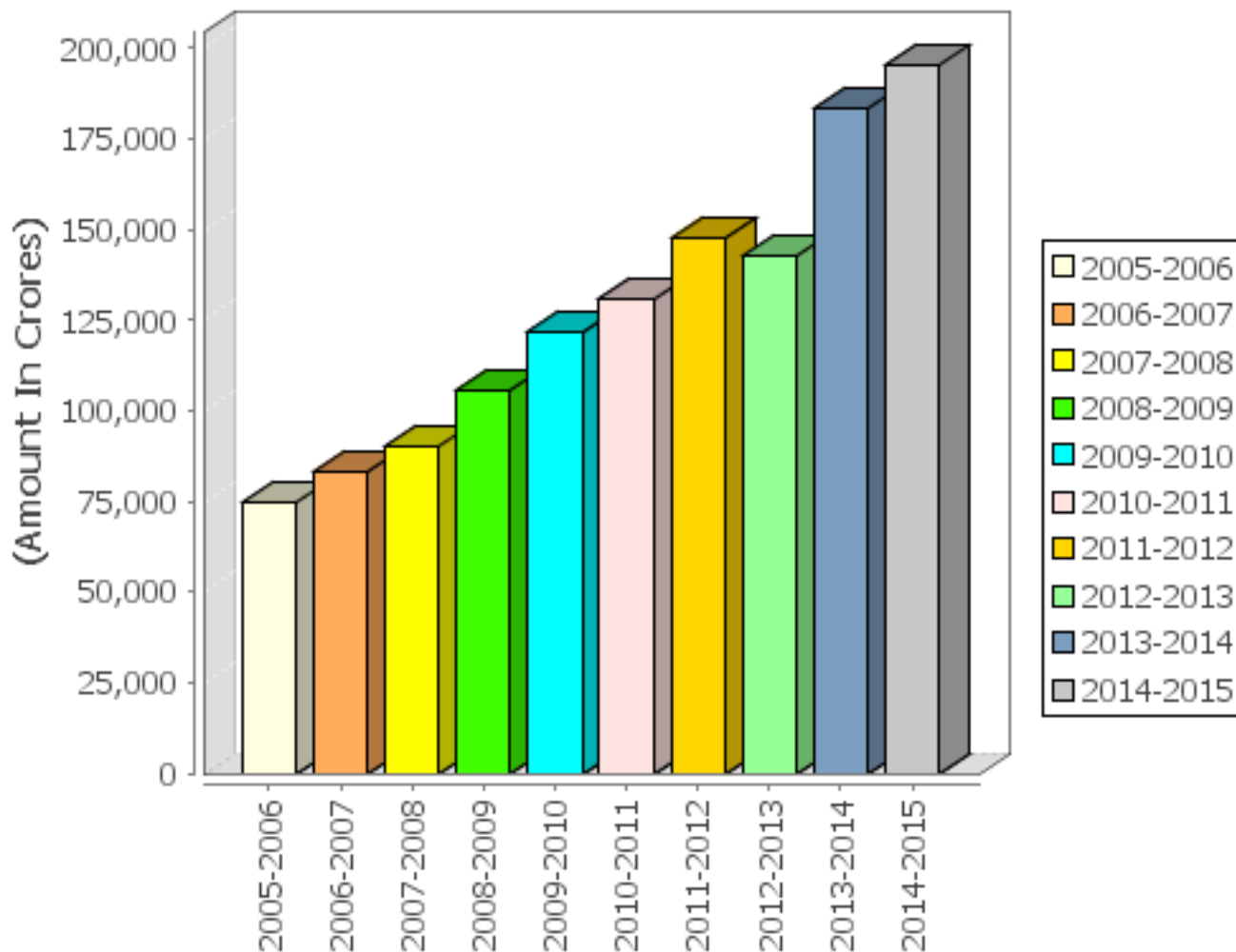

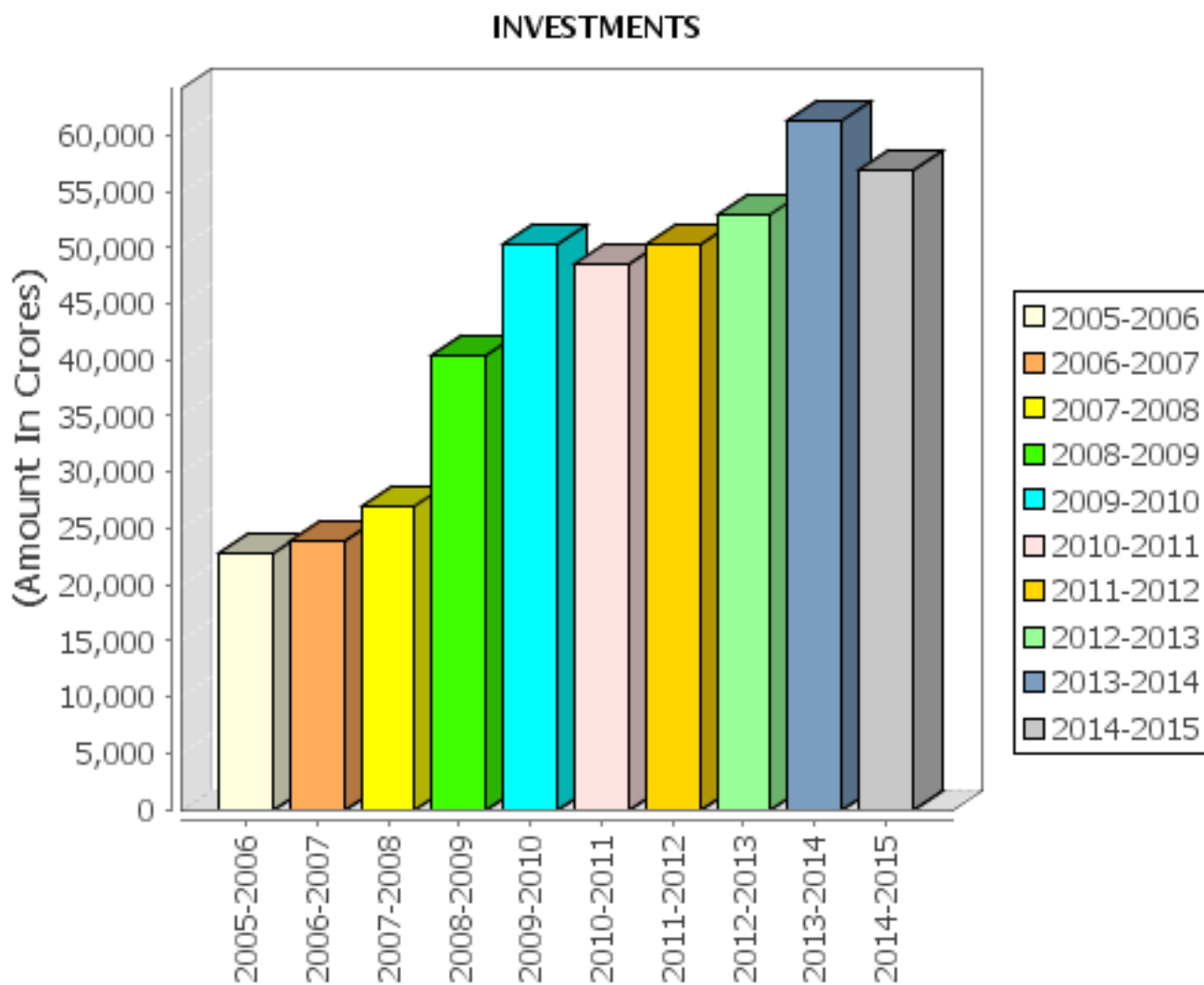
WORKING CAPITAL

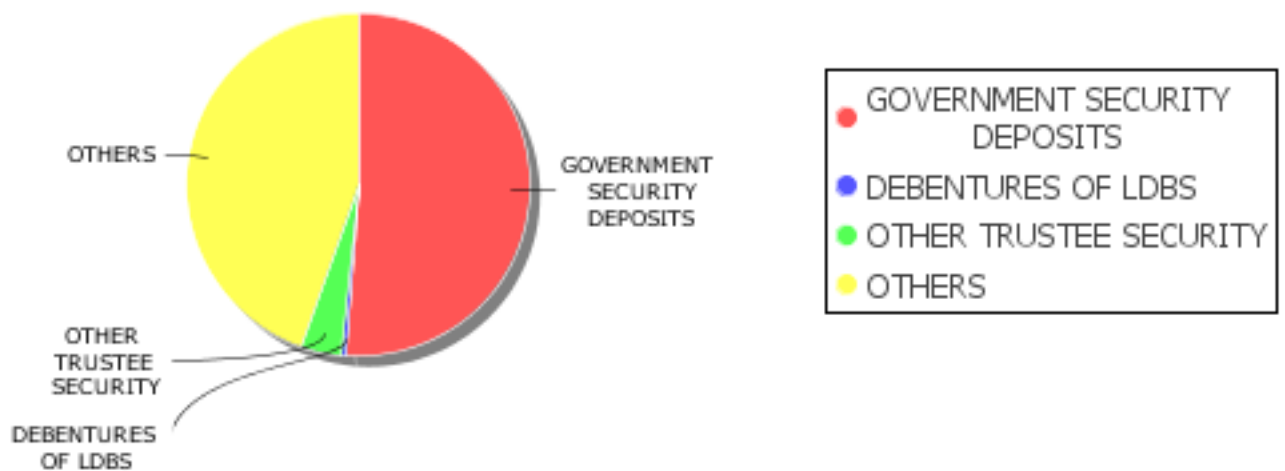

PERFORMANCE OF STATE COOPERATIVE BANKS DURING THE YEAR (2014-2015)

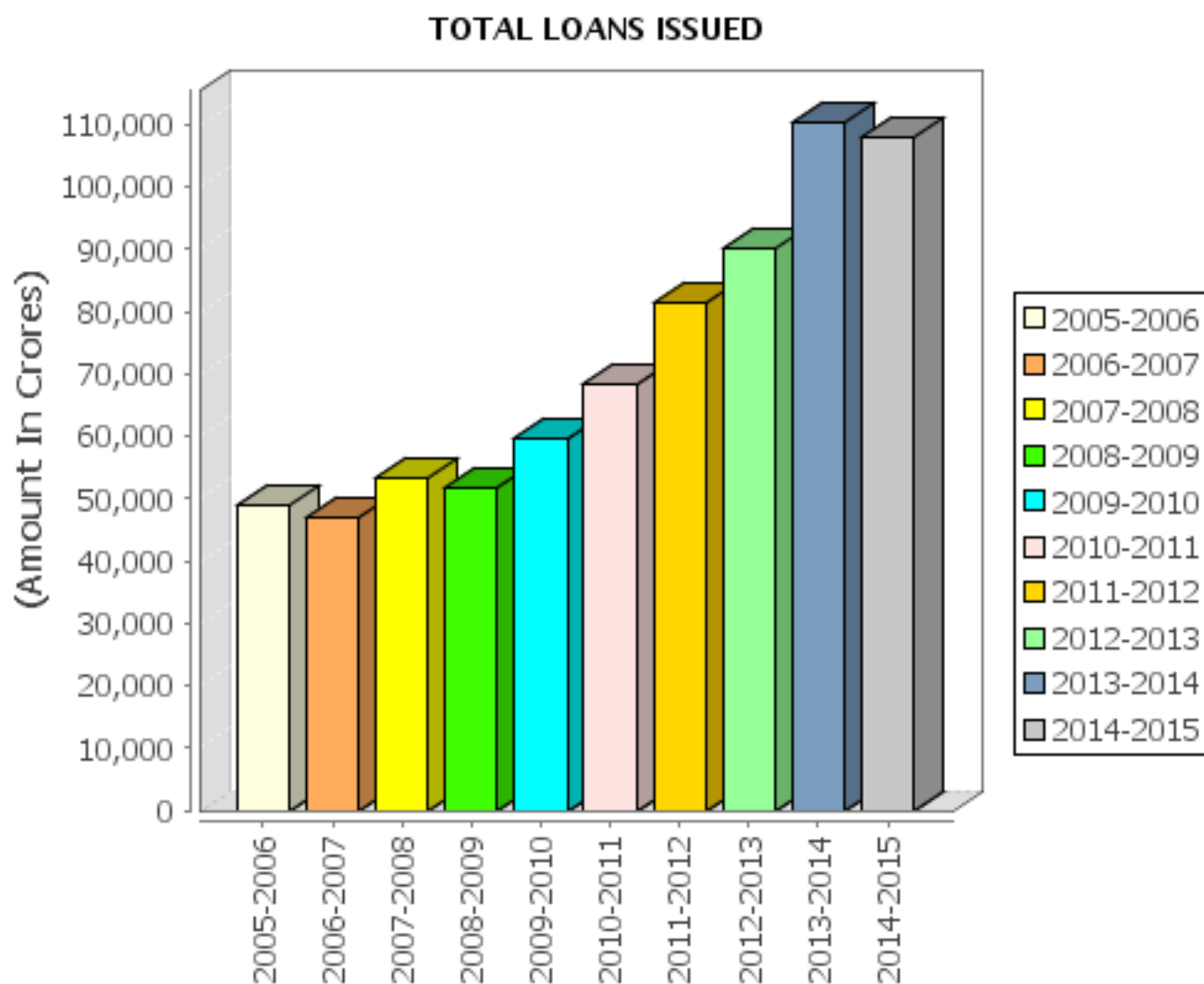
COMPOSITION OF INVESTMENTS

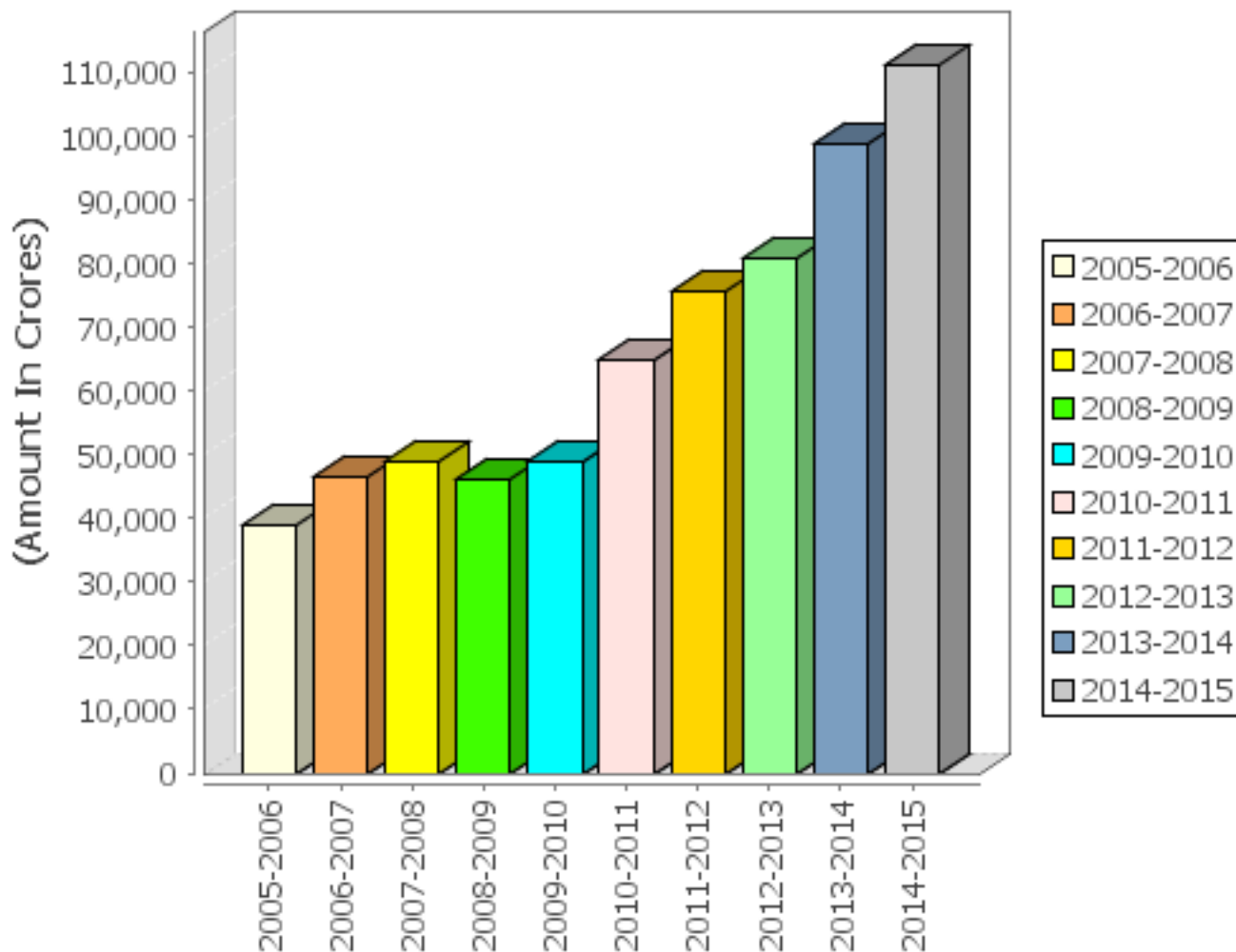

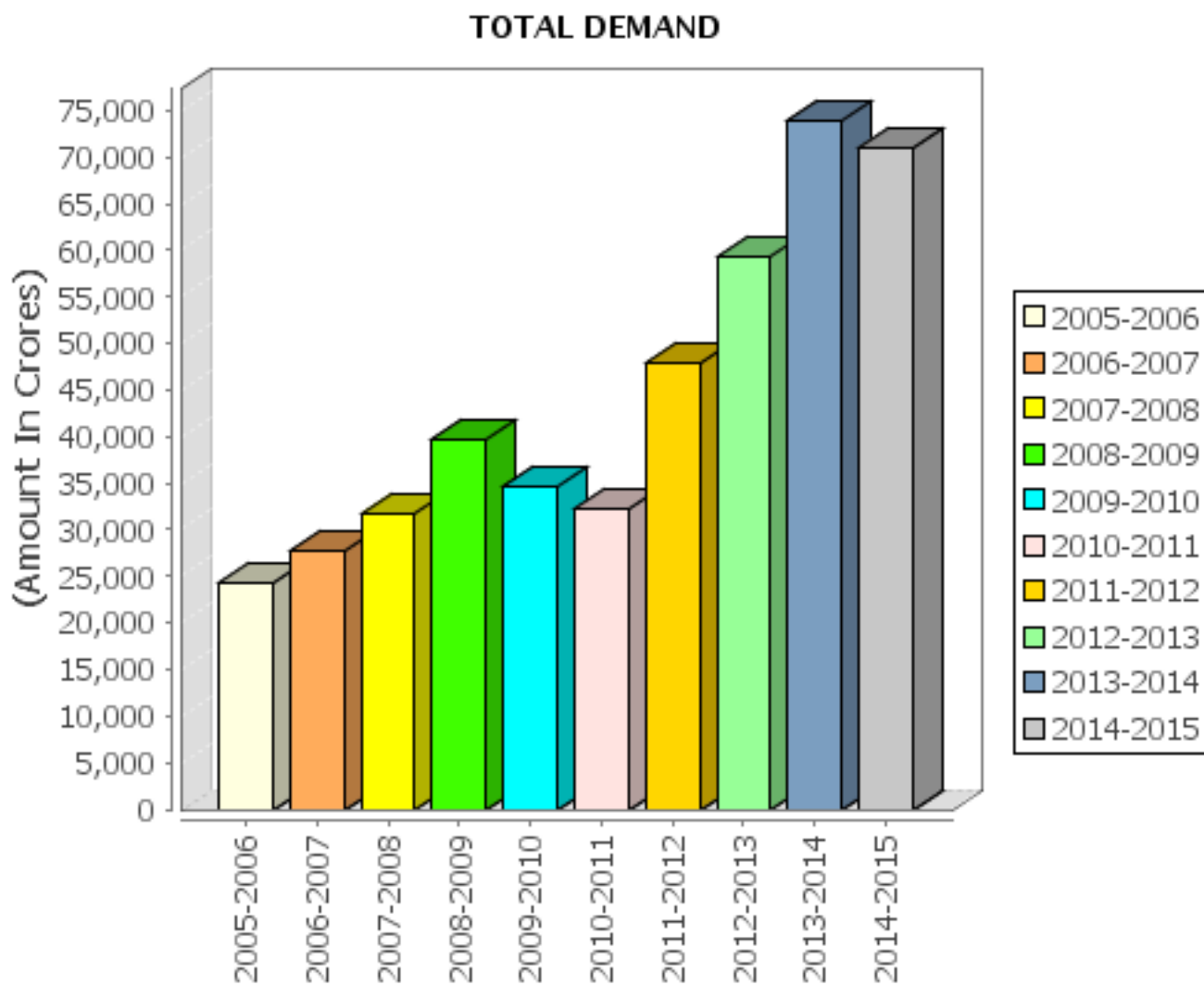
TOTAL LOANS OUTSTANDING

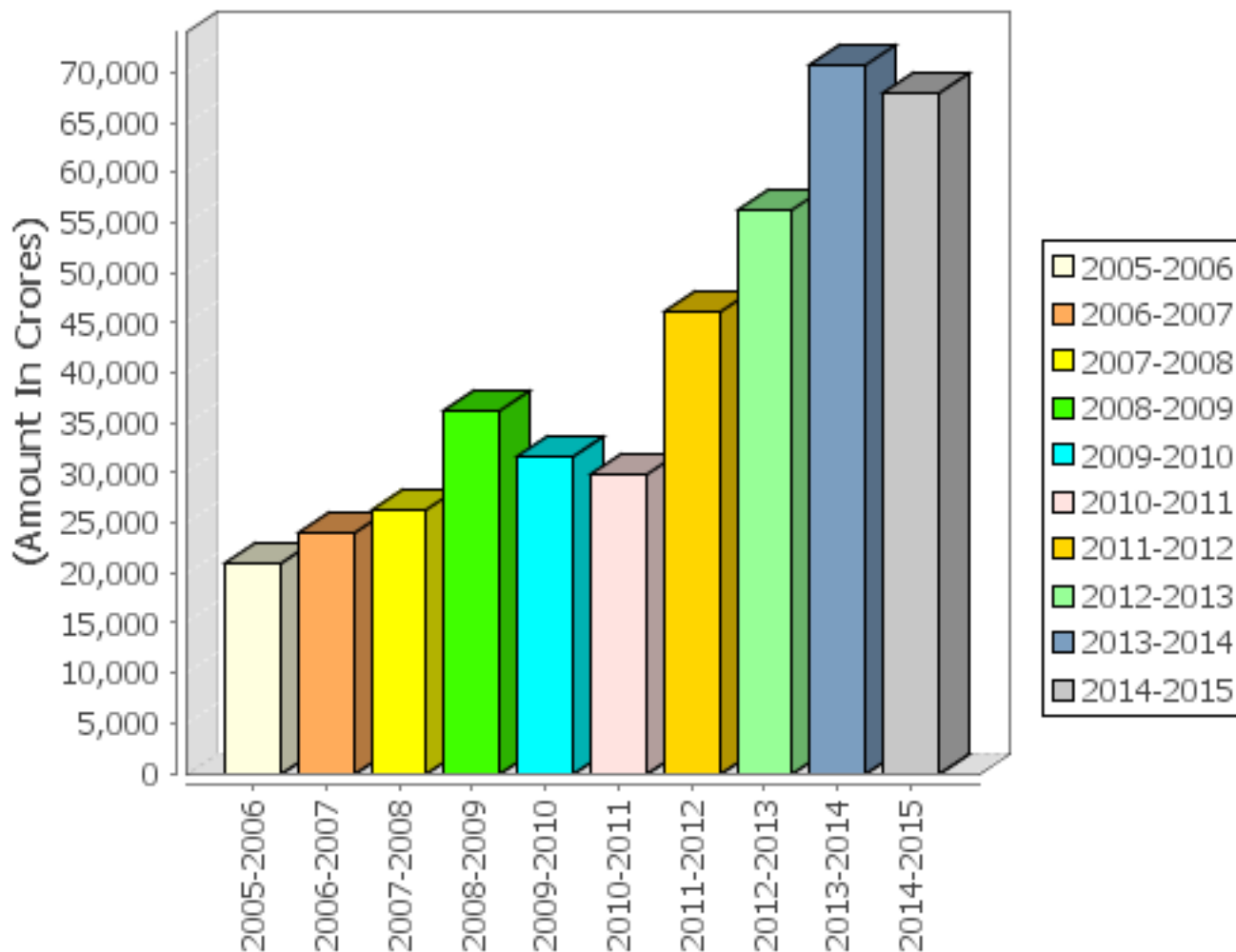

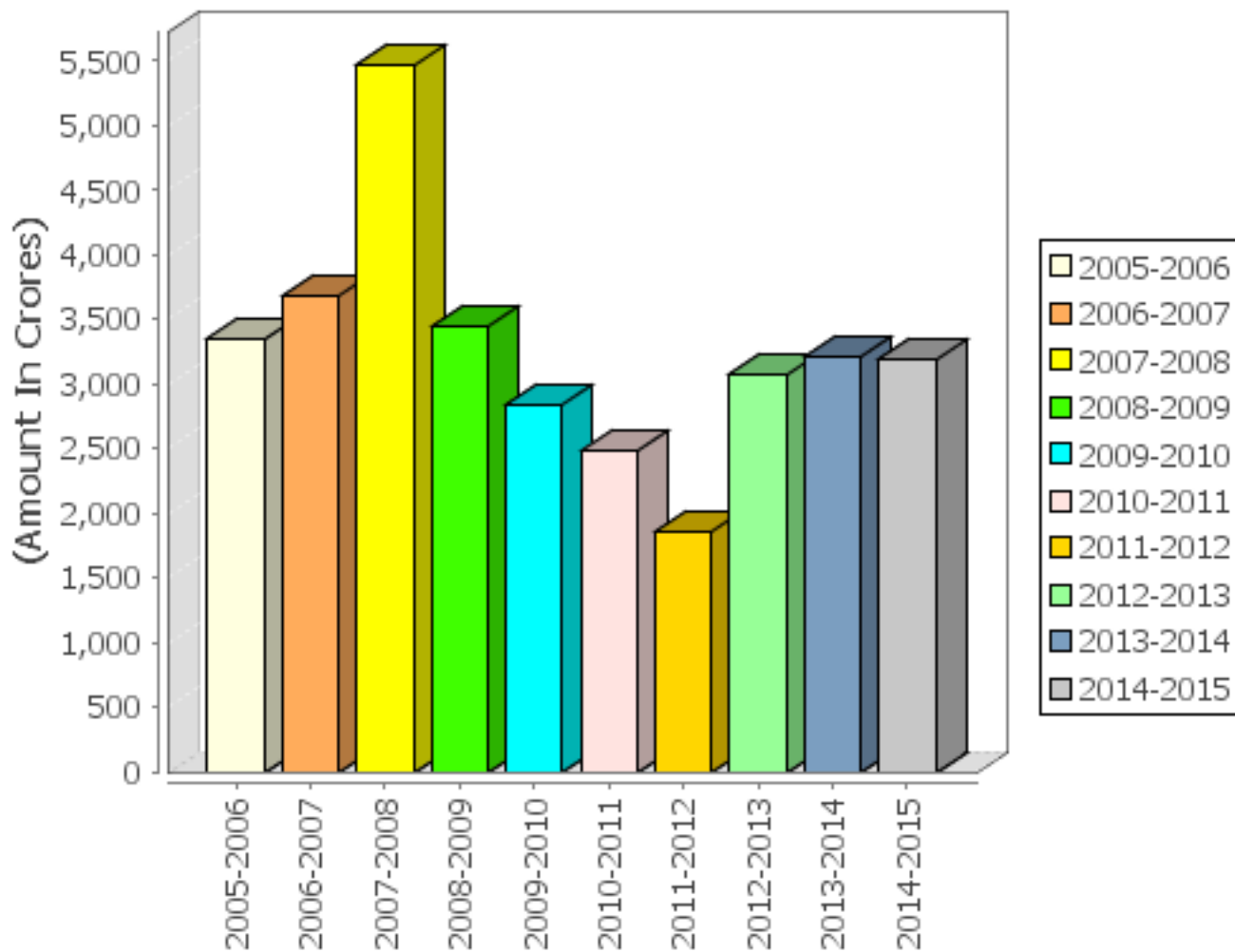

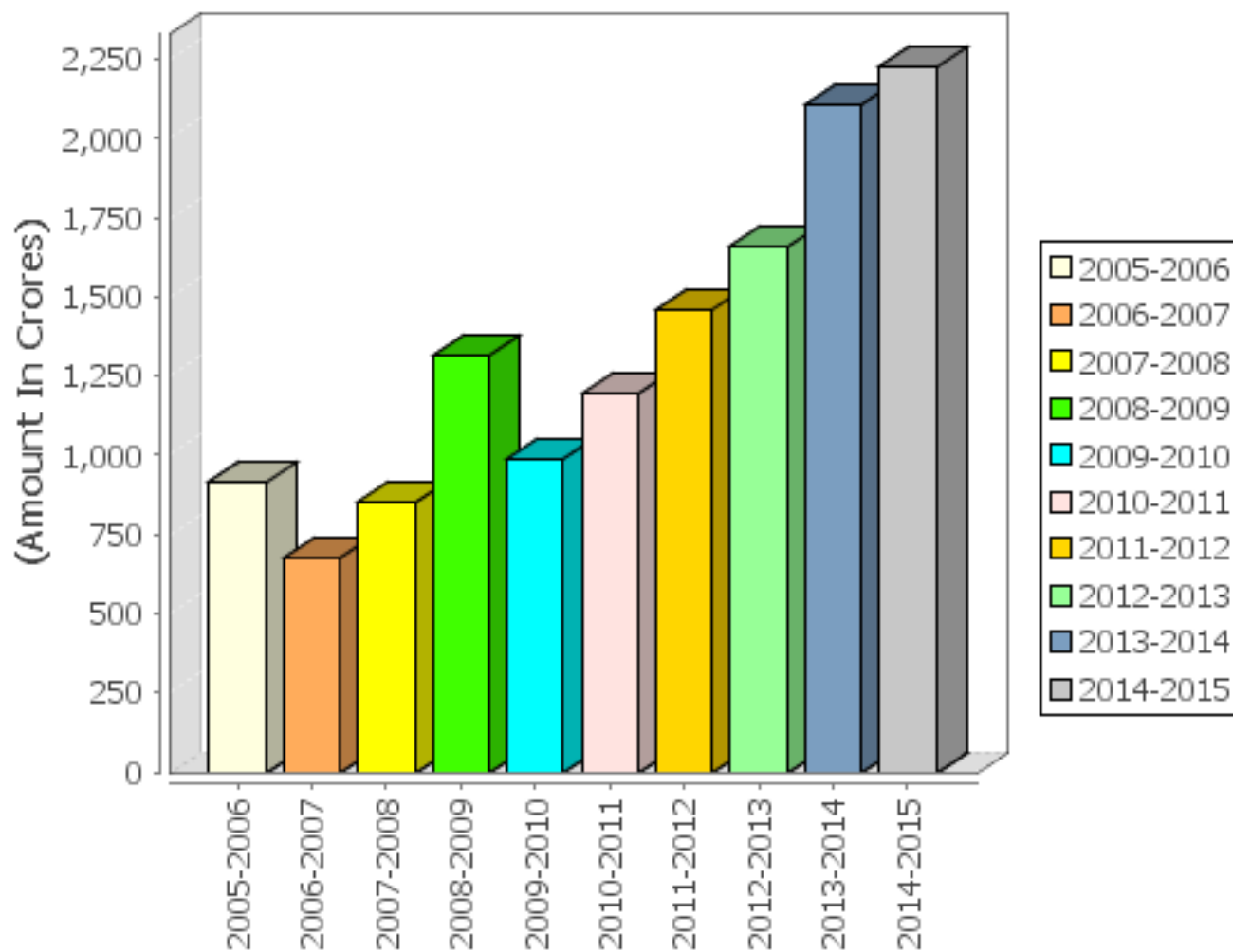

COST OF MANAGEMENT (CM)

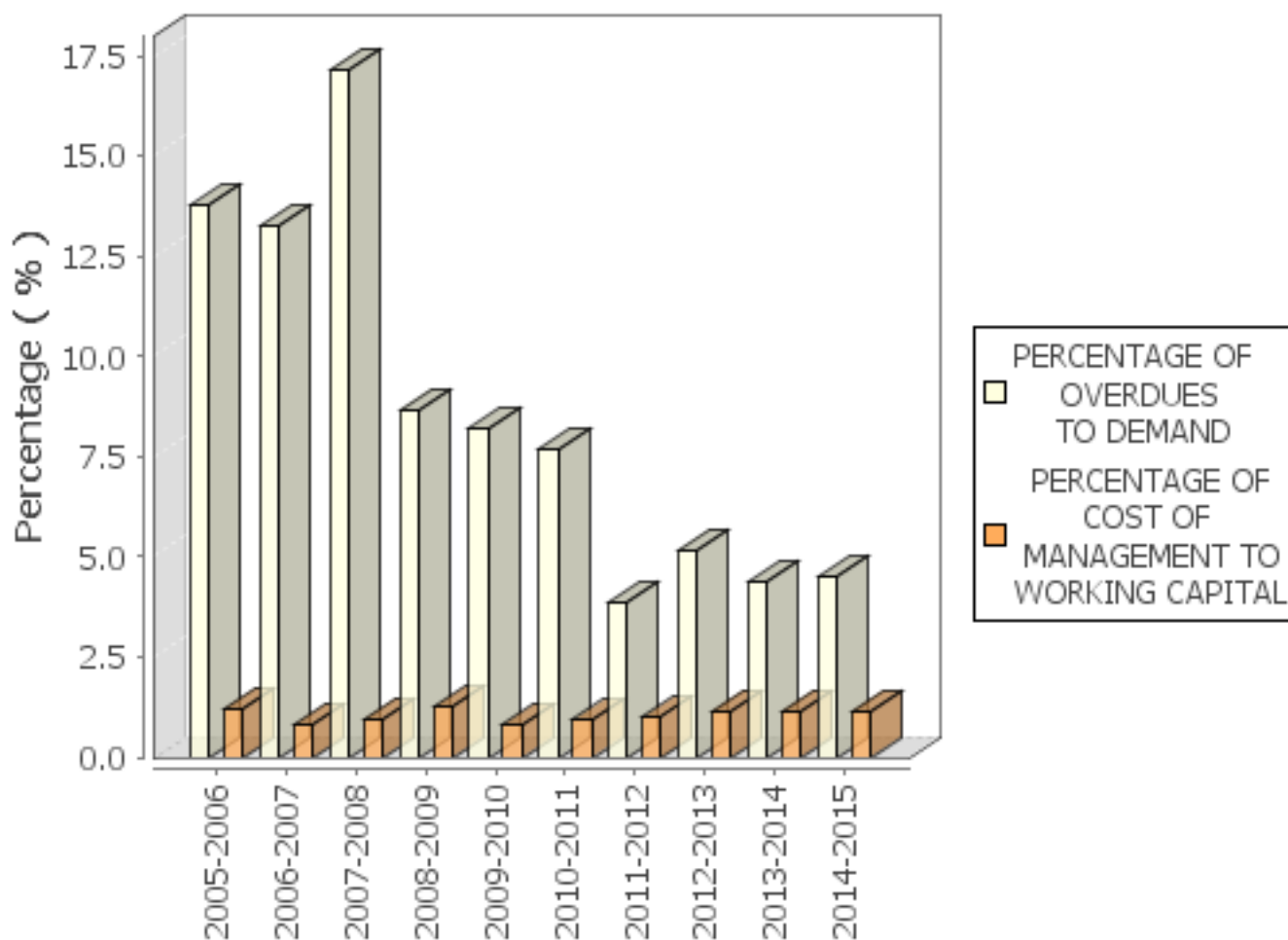

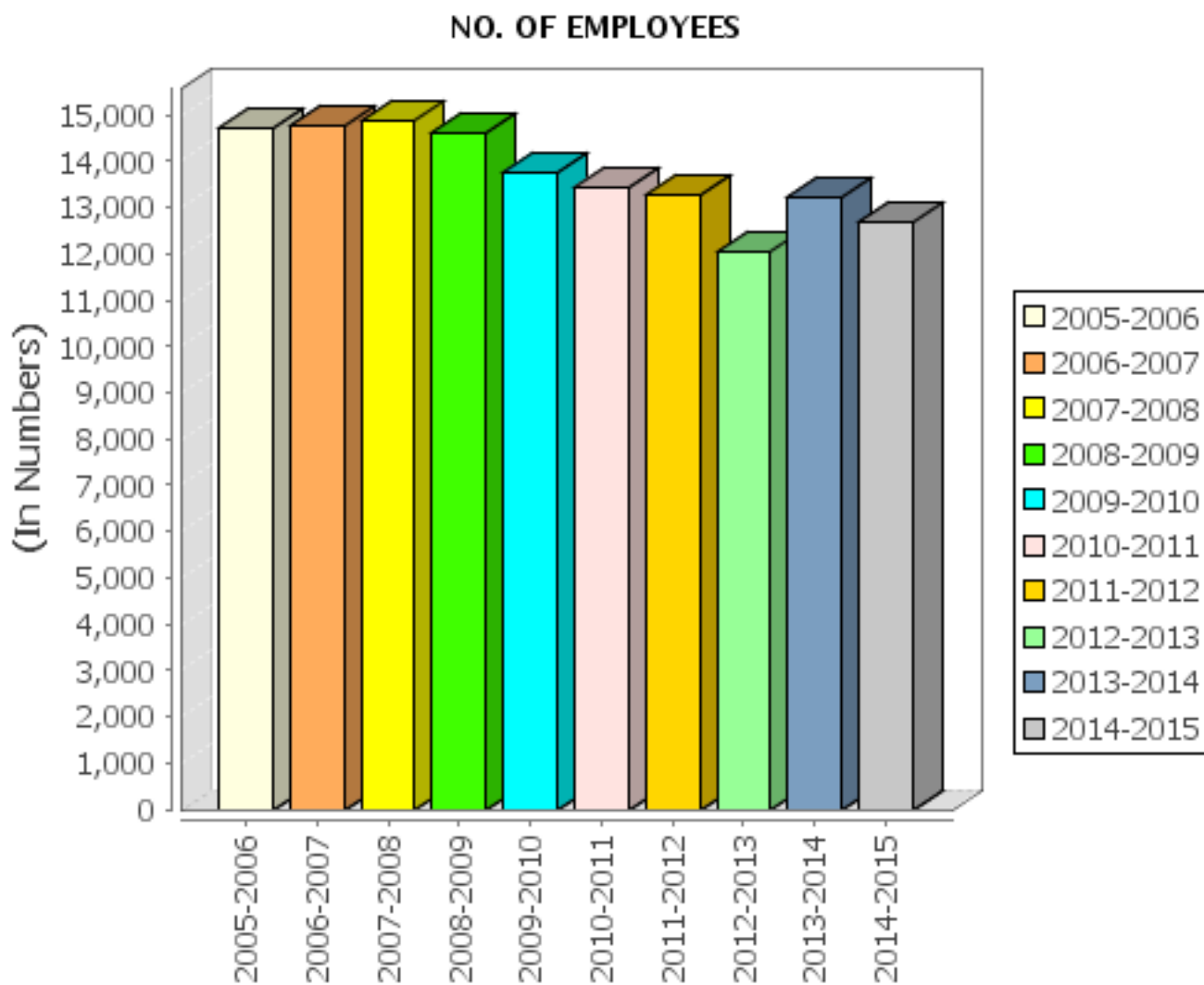

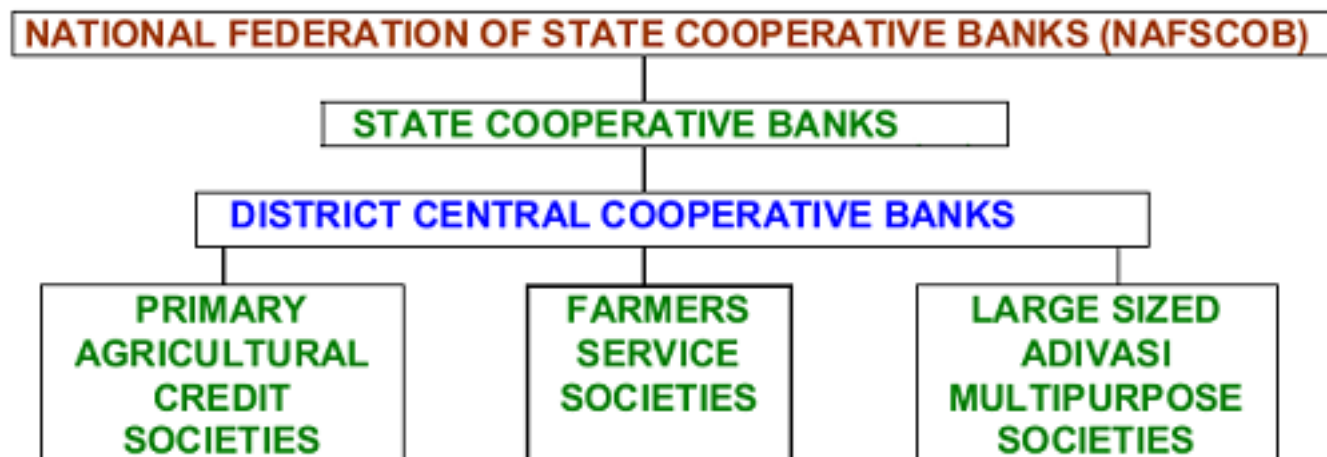
